28 ORDER TO EXTEND EXPERT DISCOVERY

1 The parties have stipulated to a limited modification of the expert discovery schedule in light of
2 an injury suffered by the United States' retained expert. I hereby find that good cause exists pursuant to
3 Fed. R. Civ. P. 16(b)(4) to justify the modification agreed upon by the parties. Accordingly:

- 4 1. Although the parties will disclose amongst themselves the name, address, and area of
5 expertise of each expert they propose to tender at trial not later than April 21, 2017, exchange
6 of expert written reports under Fed. R. Civ. P. 26(a)(2)(B) shall be moved from April 21,
7 2017 to May 3, 2017.
- 8 2. The supplemental expert disclosure deadline shall be moved from May 5, 2017 to May 12,
9 2017.
- 10 3. The date for completion of all expert discovery shall be moved from June 2, 2017 to June 12,
11 2017.
- 12 4. All other dates contained in the pretrial order, including the trial date, shall remain in place.
