
1 The court has reviewed the file and finds the findings and recommendations to be
2 supported by the record and by the magistrate judge's analysis. Accordingly, IT IS
3 HEREBY ORDERED AND AJUDGED that:

4 1. ACIC is awarded damages in the amount of \$528,574.44, plus prejudgment
5 interest at the rate of 10% per annum against HUBZONE, CORP., a California
6 corporation; and LARRY DEON LOFTON, an individual commencing:

- 7 a. April 11, 2016 for \$59,290.00;
- 8 b. May 31, 2016, for \$93,943.51;
- 9 c. August 10, 2016, for \$2,725.00;
- 10 d. August 17, 2016, for \$75,264.00;
- 11 e. November 14, 2016, for \$61,490.85;
- 12 f. November 22, 2016, for \$24,580.00;
- 13 g. March 16, 2017, for \$27,320.50; and
- 14 h. December 20, 2017, for \$183,960.58.

15 2. ACIC is awarded attorney's fees in the amount of \$14,952.00 against
16 HUBZONE, CORP., a California corporation; and LARRY DEON LOFTON, an
17 individual.
