1 Pursuant to Local Rule 143, all parties hereby request the Court's approval of
2 the following stipulation amending the Amended Scheduling Order (Dkt. 24) to
3 modify the discovery deadline as stated below:

4 **STIPULATION**

5 WHEREAS, the Pretrial Scheduling Order states that the deadline for the
6 completion of discovery, other than expert discovery, is January 30, 2017;

7 WHEREAS, the Court previously amended the scheduling order to extend
8 expert discovery to March 1, 2017;

9 WHEREAS, the parties are engaged in ongoing efforts to meet and confer on
10 discovery issues to avoid the need for discovery motions and these efforts will be
11 promoted by amending the discovery deadline to match the expert discovery
12 deadline on March 1, 2017;

13 WHEREAS, good cause exists for the Court to approve this stipulation so
14 that the parties have adequate time to complete discovery and resolve any discovery
15 disputes (with the mutual goal of resolving such disputes out of court);

16 NOW, THEREFORE, THE PARTIES STIPULATE AS FOLLOWS:

- 17 (1) Section IV of the Amended Pretrial Scheduling Order (Dkt. 24) is
18 amended to extend the time for the completion of discovery to March
19 1, 2017;
- 20 (2) This Stipulation shall become effective only upon the filing of the
21 Court's Order approving this Stipulation (or an amended Scheduling
22 Order).
