[PROPOSED] ORDER GRANTING DEFENDANTS' MOTION FOR ATTORNEYS' FEES AND COSTS


1 On November 20, 2018 at approximately 1:30 p.m., Defendants
2 SONIC INDUSTRIES LLC, SONIC FRANCHISING LLC and SONIC INDUSTRIES
3 SERVICES, INC.'s ("the Sonic Entities") motion for attorneys'
4 fees came on calendar for hearing in the above-entitled Court.
5 Lonnie D. Giamela, Esq. of Fisher & Phillips LLP appeared for the
6 Sonic Entities. Jocelyn Burton, Esq. of Burton Employment Law
7 appeared for Plaintiff.

8 Having reviewed and considered all papers in support of the
9 Sonic Entities' motion for summary judgment and hearing the
10 parties' oral arguments, the Court made the following rulings:

- 11 • The Court granted the Sonic Entities' motion for
12 attorneys' fees and awarded attorneys' fees in favor of
13 the Sonic Entities and against Plaintiff Sarah Early
14 and her guardian ad litem, Jason Early, in the amount
15 of \$17,904.63;
- 16 • The Court also considered the Sonic Entities' bill of
17 costs and awarded costs in favor of the Sonic Entities
18 and against Plaintiff Sarah Early and her guardian ad
19 litem, Jason Early, in the amount of \$1,552.85.
