16 WHEREAS the parties agree that a continuance of the dates concerning disclosure of expert
 17 witnesses is in their mutual interest.

18 The parties have agreed to engage in mediation with Eric Emanuels, Esq. in Sacramento,
 19 California. Based on the availability of the mediator and all parties involved, mediation is
 20 scheduled for September 20, 2017. It is the parties' intent to engage in early mediation prior to the
 21 parties engaging in the time and cost of further discovery, expert disclosures and expert discovery,
 22 to promote settlement discussions.

23 An extension of time for expert disclosures is necessary to allow time for the completion of
 24 mediation on September 20, 2017. Additionally, should mediation not be successful, the
 25 depositions of plaintiff's treating physicians will need to be completed, which are necessary for
