**JOINT STIPULATION AND
[PROPOSED] ORDER EXTENDING

FILING DEADLINE**

18 IT IS HEREBY STIPULATED by and between, Plaintiff Michael McCormack
19 ("Plaintiff"), on the one hand, and Defendants County of Sacramento and Sean Woodward
20 ("Defendants", and collectively referred to herein as "the Parties"), on the other hand, by and
21 through their respective attorneys of record as follows:

22 Whereas the County of Sacramento has formally approved of the settlement arrived at
23 between the parties during the settlement conference of June 1, 2017, but has yet to complete
24 processing of the settlement draft.

25 Whereas the Parties have executed a settlement agreement and release as well as a
26 stipulated dismissal with prejudice.

27 Whereas the terms of the settlement agreement and release provide that Defendants
28 cannot file the stipulated dismissal with prejudice until delivery of the settlement draft to

1 Plaintiff's counsel.

2 Whereas Defendants have been advised by the County of Sacramento that the settlement
3 draft is currently being processed and delivery thereof should occur sometime later this week or
4 early next week.

5 It is therefore STIPULATED AND AGREED, by and between the Parties that the
6 deadline for filing of dispositional documents should be extended from August 1, 2017 for an
7 additional two weeks until August 15, 2017.
