 18 Plaintiff MERVIN SWANSON and Defendants KEYSTONE RV COMPANY and  
 19 Defendant JAMES B. TUCK ENTERPRISES, INC. dba FUN CARS/TOY HAULER  
 20 LIQUIDATORS, enter into the following stipulation:

- 21 1. The Parties agree to refer this dispute to the Court’s Voluntary Dispute Resolution  
 22 Program [hereinafter “VDRP”] pursuant to Local Rule 271.
- 23 2. The VDRP process shall be completed by the Parties on or before January 20, 2017  
 24 and the Neutral shall file confirmation of completion of the process no later than January 31,  
 25 2017.
- 26 3. The Parties may propound Interrogatories or Requests for Production of Documents  
 27 during the time the case is referred to VDRP and Defendants may also serve a Request for  
 28 Inspection regarding the Travel Trailer that is the subject matter of the dispute while the case is

1 referred to VDRP. All other discovery shall be stayed until after completion of the VDRP  
2 process.

17 **ORDER**


18 The parties' agreement regarding discovery is APPROVED. This matter is referred to

24 initial scheduling report required by this court's standing order by February 23, 2017. This case  
25 is set for an initial scheduling status conference on March 2, 2017, at 2:30 p.m.
