Accordingly, the assignment of 18 the matters to the same judge is likely to effect a substantial saving of judicial effort and is also likely to be convenient for 19 20 the parties. The parties should be aware that relating the cases 21 2.2 under Local Rule 123 merely has the result that both actions are 23 assigned to the same judge; no consolidation of the actions is effected.
