29 Plaintiff's counsel John McCauley and Defense counsel Laraya M. Parnell and Jon Allin
 30 appeared before Judge Mueller for a status conference on January 31, 2019, regarding trial.
 31 During the status conference, the Court ordered the parties to file a joint supplemental status
 32

1 report addressing several matters related to trial after Plaintiff's counsel had an opportunity to
2 meet with Plaintiff. (ECF No. 63.)

3 The parties met and conferred regarding the status of the case on February 14, 2019. The
4 parties have determined that an extension of time is necessary because Plaintiff's counsel has not
5 had the opportunity to meet with his client. Plaintiff's counsel was granted clearance to visit
6 Plaintiff on February 14, 2019. Plaintiff's counsel is currently scheduled to visit California State
7 Prison, Corcoran to meet with Plaintiff on March 11, 2019, to discuss the case and the questions
8 presented by the Court in the minute order. The parties have agreed to further meet and confer in
9 order to complete the joint supplemental status report after Plaintiff's counsel has the opportunity
10 to meet with Plaintiff.

11 Accordingly, the parties request a forty-five-day extension of time, to Monday, April 8,
12 2019, to file the requested joint supplemental status report.
