1 The parties to the above-captioned action, by and through their undersigned
2 attorneys, hereby stipulate as follows:

3 1. The Certified Administrative Record (CAR) filed on February 23, 2017
4 (Docket No. 16), has been determined to be incomplete. Specifically, the CAR does not
5 contain a transcript of the oral hearing that took place on December 8, 2014. Defendant
6 will file a Supplemental Certified Administrative Record within three (3) days, on or
7 before May 26, 2017, to include the missing transcript.

8 2. The briefing schedule shall be modified, such that Plaintiff shall have thirty


