**STIPULATION TO MODIFY STATUS

WHEREAS on August 26, 2015 an action was commenced in the Superior Court of the

1 State of California in and for the County of Sacramento, entitled *Maurice D. Johnson, Sr.*,

15 discovery in hopes of resolving the matter at the settlement conference, desire to stipulate to a  
16 modification of the scheduling order;

17 THEREFORE, the parties hereby stipulate, by and through their counsel of record, as  
18 follows:

19 1. That the current scheduling order be modified to extend the date of expert  
20 disclosures to September 15, 2017;

21 2. That the current scheduling order be modified to extend fact discovery to be  
22 completed by October 6, 2017;

23 3. That all other dates in the pretrial scheduling order remain the same.
