13 incorrect international telephone prefix for calling counsel in the United States and inadvertently
14 omitted contact information for Plaintiffs' counsel in Mexico.

15 The parties therefore agree that the concurrently filed corrected English and Spanish
16 language class notices shall replace the notices previously approved by the Court.
