
1 The deadline to complete discovery, as set forth in Paragraph IV of the Pre-
2 Trial Scheduling Order will be extended to **April 16, 2018.**

3 The expert disclosure deadline as set forth in Paragraph V of the Pre-Trial
4 Scheduling Order will be extended to **June 21, 2018.**

5 The dispositive motion deadline as set forth in Paragraph VI of the Pre-Trial
6 Scheduling Order will be extended to **August 23, 2018.** Plaintiffs and Defendant will
7 complete all discovery of expert witnesses in a timely manner, as set forth in
8 Paragraph V to the PTSO, to comply with the new deadline for filing dispositive
9 motions.
