The Sheriff of Solano County or a designee shall collect from plaintiff's inmate trust 3 account an initial partial filing fee in accordance with the provisions of 28 U.S.C. § 1915(b)(1) as 4 set forth in this order and shall forward the amount to the Clerk of the Court. The payment shall 5 be clearly identified by the name and number assigned to this action. 6 2. Thereafter, the Sheriff of Solano County or a designee shall collect from plaintiff's 7 inmate trust account monthly payments from plaintiff's inmate trust account in an amount equal 8 to twenty percent (20%) of the preceding month's income credited to the inmate's trust account 9 and forward payments to the Clerk of the Court each time the amount in the account exceeds 10 \$10.00 in accordance with 28 U.S.C. \ 1915(b)(2), until the \\$350.00 filing fee for this action has 11 been paid in full. The payments shall be clearly identified by the name and number assigned to 12 this action. 13 3.
