- 2. Under 18 U.S.C. §§ 983(a)(1)(A)(i)-(iii) and 983(a)(3)(A), the United States is required to send notice to potential claimants, file a complaint for forfeiture against the defendant currency and defendant funds, or obtain an indictment alleging that the defendant currency and defendant funds are subject to forfeiture within sixty days of seizure, unless the court extends the deadline for good cause shown or by agreement of the parties. That deadline was May 28, 2016.
- 3. By Stipulation and Order filed June 2, 2016, the parties stipulated to extend to August 26, 2016, the time in which the United States is required to file a civil complaint for forfeiture against the defendant currency and/or to obtain an indictment alleging that the defendant currency is subject to forfeiture.
- 4. By Stipulation and Order filed August 29, 2016, the parties stipulated to extend to November 25, 2016, the time in which the United States is required to file a civil complaint for forfeiture against the defendant currency and/or to obtain an indictment alleging that the defendant currency is subject to forfeiture.
- 5. As provided in 18 U.S.C. § 983(a)(3)(A), the parties wish by agreement to extend to January 24, 2017, the time in which the United States is required to file a civil complaint for forfeiture against the defendant currency and defendant funds and/or to obtain an indictment alleging that the defendant currency and defendant funds are subject to forfeiture.
