1	2. The Clerk of the Court is directed to:		
2	a. Serve the undersigned's scheduling order in social security cases;		
3	b. Serve a copy of this order on the United States Marshal; and		
4	c. Send plaintiff one USM-285, one summons, a copy of the complaint, and an		
5	appropriate form for consent to trial by a magistrate judge.		
6	3. Plaintiff is directed to supply the U.S. Marshal, within 15 days from the date of this		
7	order, all information needed by the Marshal to effect service of process, and shall promptly file		
8	a statement with the court that said documents have been submitted to the United States		
9	Marshal (see attachment). The court anticipates that, to effect service, the U.S. Marshal will		
10	require, at least:		
11	a. One completed summons;		
12	b. One completed USM-285 form;		
13	c. One copy of the endorsed filed complaint, with an extra copy for the U.S.		
14	Marshal;		
15	d. One copy of the instant order; and
