**STIPULATION AND ORDER FOR

24 Whereas, this Court issued the BRIEFING SCHEDULE IN BANKRUPTCY APPEAL on
25 March 16, 2017 [Doc. No. 3-1] providing that appellant’s opening brief and excerpts of record are
26 due within thirty (30) days of said date, appellee’s opening brief is due within thirty (30) days
27 after service of appellant’s brief, and that appellant may file a reply brief within fourteen (14) days
28 after service of appellee’s brief.

Whereas, this Court issued an Order Granting Extension of Time to File Briefs on April
19, 2017 [Doc. No. 6] providing that appellant’s opening brief and excerpts of record are due on or
before May 17, 2017, appellee’s opening brief is due within thirty (30) days after service of

1 appellant's brief, and that appellant may file a reply brief within fourteen (14) days after service of
2 appellee's brief.

3 Whereas, appellant's brief and excerpts of record were filed on May 17, 2017 [Doc. Nos.
4 12 and 12-1] and appellee's brief and supplemental excerpts of record were filed on June 16, 2017
5 [Doc. Nos. 16 and 17]. Appellant's reply brief is due within fourteen (14) days of appellee's brief,
6 June 30, 2017.

7 The parties hereto stipulate to an extension of said filing deadline for appellant's reply
8 brief as set forth below:

- 9 1. Appellant may file a reply brief with the District Court on or before July 7, 2017.
