1 As set forth below, Plaintiff Kellie Gadomski (“Plaintiff”) and Defendant
2 Equifax Information Services LLC (“Equifax”) stipulate to an extension of time for
3 Equifax to respond to the First Amended Complaint.

4 WHEREAS, Plaintiff served her First Amended Complaint on June 6, 2018,


