
9 Examination of the above-entitled actions reveals that they are related within the meaning
10 of Local Rule 123(a). The actions are based on the same claims, the same questions of fact and
11 the same questions of law, and would therefore entail a substantial duplication of labor if heard by
12 different judges. Accordingly, the assignment of the matters to the same judge is likely to affect a
13 substantial savings of judicial effort and is also likely to be convenient for the parties.

14 The parties should be aware that relating the cases under Local Rule 123 merely has the
15 result that these actions are assigned to the same judge. No consolidation of the actions is
16 affected. Under the regular practice of this court, related cases are generally assigned to the judge
17 and magistrate judge to whom the first filed action was assigned.

18 IT IS THEREFORE ORDERED that the actions denominated 2:17-cv-00811-WBS-GGS
19 and 2:17-cv-00816-TLN-KJN are hereby reassigned to District Judge Troy L. Nunley and
20 Magistrate Judge Allison Claire for all further proceedings. Any dates currently set in the
21 reassigned cases are hereby VACATED. Henceforth, the caption on documents filed in the
22 reassigned cases shall be shown as 2:17-cv-00811-TLN-AC and 2:17-cv-00816-TLN-AC,
23 respectively.

24 IT IS FURTHER ORDERED that the Clerk of Court make appropriate adjustment in the
25 assignment of civil cases to compensate for this reassignment and issue.
