The Clerk shall file under seal the documents that Genentech lodged with its Request.

Access to the sealed documents shall be limited to attorneys of record, parties, and Court personnel.

Within seven (7) days of entry of this Order, Genentech shall file on the public docket versions of the documents specified above with Genentech's proposed reductions applied.
