The payment shall 5 be clearly identified by the name and number assigned to this action. 6 2. Thereafter, the Sheriff of Solano County or a designee shall collect from plaintiff's 7 inmate trust account monthly payments in an amount equal to twenty percent (20%) of the 8 preceding month's income credited to the inmate's trust account and forward payments to the 9 Clerk of the Court each time the amount in the account exceeds \$10.00 in accordance with 28 10 U.S.C. § 1915(b)(2), until the \$350.00 filing fee for this action has been paid in full. The 11 payments shall be clearly identified by the name and number assigned to this action. 12 3.
