18 1. All parties hereby stipulate and request that the Court enter an order  
 19 revising the briefing schedule as set forth below. Good cause exists for the request:

21 WHEREAS, Plaintiff filed her Complaint on August 8, 2017, and Defendant  
 22 filed its Answer on November 30, 2017 and lodged the administrative transcript on  
 23 November 30, 2017.

25 WHEREAS, Plaintiff filed her Motion for Summary Judgment on January  
 26 16, 2018 and an Amended Motion for Summary Judgment on January 18, 2018.

28 STIPULATION AND [PROPOSED] ORDER FOR REVISED BRIEFING SCHEDULE

1 Defendant filed its Opposition to the Plaintiff's First Amended Motion for  
2 Summary Judgment and its Cross-Motion for Summary Judgment on February 15,  
3 2018.  
4

5 WHEREAS, on March 7, 2018, Plaintiff's counsel realized that several  
6 citations to the record in its First Amended Summary Judgment Motion were  
7 incorrect. This was the result of an inadvertent administrative error on the part of  
8 Plaintiff's counsel where they cited to the downloaded version of the ERE file  
9 instead of the administrative record provided by the Defendant.

12 WHEREAS, Plaintiff's counsel promptly contacted the Defendant and was  
13 amenable to a new stipulated briefing schedule so that this correction could be  
14 made.
