10 request that the Court extend the time for Defendants TCB Imports and Todd C.

12 and TCBOverstock to respond to the Amended Complaint and Motion for  
13 Preliminary Injunction ("PI Motion") filed by Plaintiffs Audi AG, Bentley Motors

15 Bentley"). The parties also request that the Court continue the hearing date for  
16 Audi's and Bentley's Motion for Preliminary Injunction so that the parties can

18 agree and hereby stipulate that the defendants shall be allowed to extend the  
19 deadline to respond to Audi's and Bentley's Motion and Complaint, as follows:

5 any such opposition to Audi's and Bentley's Motion for Preliminary Injunction  
6 filed by the defendants; and

8           4. The hearing on Audi's and Bentley's Motion for Preliminary Injunction  
9 shall be continued to November 17, 2017, at 10:00 AM in Courtroom 3 before  
10 Judge Kimberly J. Mueller.
