#### PURPOSES AND LIMITATIONS

2 Disclosure and discovery activity in this action are likely to involve production of 3 confidential, proprietary, or private information for which special protection from public disclosure 4 and from use for any purpose other than prosecuting this litigation may be warranted. Accordingly, 5 the parties hereby stipulate to and petition the court to enter the following Stipulated Protective 6 Order. The parties acknowledge that this Order does not confer blanket protections on all 7 disclosures or responses to discovery and that the protection it affords from public disclosure and 8 use extends only to the limited information or items that are entitled to confidential treatment under 9 the applicable legal principles. The parties further acknowledge, as set forth in Section 12.3, below, 10 that this Stipulated Protective Order does not entitle them to file confidential information under 11 seal; Civil Local Rule 79-5 sets forth the procedures that must be followed and the standards that 12 will be applied when a party seeks permission from the court to file material under seal. 13 2. DEFINITIONS 14 2.1 Challenging Party: a Party or Non-Party that challenges the designation of 15 information or items under this Order. 16 2.2 "CONFIDENTIAL" Information or Items: information (regardless of how it is 17 generated, stored or maintained) or tangible things that qualify for protection under Federal Rule of 18 Civil Procedure 26(c). 19 2.3 Counsel (without qualifier): Outside Counsel of Record and House Counsel (as well as their support staff). 20 21 2.4 <u>Designating Party</u>: a Party or Non-Party that designates information or items that it 22 produces in disclosures or in responses to discovery as "CONFIDENTIAL." 23 2.5 Disclosure or Discovery Material: all items or information, regardless of the 24 medium or manner in which it is generated, stored, or maintained (including, among other things, 25 testimony, transcripts, and tangible things), that are produced or generated in disclosures or 26 responses to discovery in this matter. 27 2.6 Expert: a person with specialized knowledge or experience in a matter pertinent to 28 the litigation who has been retained by a Party or its counsel to serve as an expert witness or as a 1

1 consultant in this action.

2 2.7 <u>House Counsel</u>: attorneys who are employees of a party to this action. House
 3 Counsel does not include Outside Counsel of Record or any other outside counsel.
 4 2.8 <u>Non-Party</u>: any natural person, partnership, corporation, association, or other legal
 5 entity not named as a Party to this action.
 6 2.9 <u>Outside Counsel of Record</u>: attorneys who are not employees of a party to this
 7 action but are retained to represent or advise a party to this action and have appeared in this action

8 on behalf of that party or are affiliated with a law firm which has appeared on behalf of that party.

9 2.10 <u>Party</u>: any party to this action, including all of its officers, directors, employees,
10 consultants, retained experts, and Outside Counsel of Record (and their support staffs).

2.11 <u>Producing Party</u>: a Party or Non-Party that produces Disclosure or Discovery
Material in this action.

2.12 <u>Professional Vendors</u>: persons or entities that provide litigation support services
(e.g., photocopying, videotaping, translating, preparing exhibits or demonstrations, and organizing,
storing, or retrieving data in any form or medium) and their employees and subcontractors.

16 2.13 <u>Protected Material</u>: any Disclosure or Discovery Material that is designated as
 17 "CONFIDENTIAL."

18 2.14 <u>Receiving Party</u>: a Party that receives Disclosure or Discovery Material from a
19 Producing Party.

20 3. <u>SCOPE</u>

21 The protections conferred by this Stipulation and Order cover not only Protected Material 22 (as defined above), but also (1) any information copied or extracted from Protected Material; (2) all 23 copies, excerpts, summaries, or compilations of Protected Material; and (3) any testimony, conversations, or presentations by Parties or their Counsel that might reveal Protected Material. 24 25 However, the protections conferred by this Stipulation and Order do not cover the following 26 information: (a) any information that is in the public domain at the time of disclosure to a 27 Receiving Party or becomes part of the public domain after its disclosure to a Receiving Party as a 28 result of publication not involving a violation of this Order, including becoming part of the public

record through trial or otherwise; and (b) any information known to the Receiving Party prior to the
 disclosure or obtained by the Receiving Party after the disclosure from a source who obtained the
 information lawfully and under no obligation of confidentiality to the Designating Party. Any use
 of Protected Material at trial shall be governed by a separate agreement or order.

5 4. <u>DURATION</u>

Even after final disposition of this litigation, the confidentiality obligations imposed by this
Order shall remain in effect until a Designating Party agrees otherwise in writing or a court order
otherwise directs. Final disposition shall be deemed to be the later of (1) dismissal of all claims and
defenses in this action, with or without prejudice; and (2) final judgment herein after the
completion and exhaustion of all appeals, rehearings, remands, trials, or reviews of this action,
including the time limits for filing any motions or applications for extension of time pursuant to
applicable law.

#### DESIGNATING PROTECTED MATERIAL

5.1 <u>Exercise of Restraint and Care in Designating Material for Protection</u>. Each Party or
Non-Party that designates information or items for protection under this Order must take care to
limit any such designation to specific material that qualifies under the appropriate standards. The
Designating Party must designate for protection only those parts of material, documents, items, or
oral or written communications that qualify – so that other portions of the material, documents,
items, or communications for which protection is not warranted are not swept unjustifiably within
the ambit of this Order.

Mass, indiscriminate, or routinized designations are prohibited. Designations that are shown
to be clearly unjustified or that have been made for an improper purpose (e.g., to unnecessarily
encumber or retard the case development process or to impose unnecessary expenses and burdens
on other parties) expose the Designating Party to sanctions.

If it comes to a Designating Party's attention that information or items that it designated for
protection do not qualify for protection, that Designating Party must promptly notify all other
Parties that it is withdrawing the mistaken designation.

1	5.2 <u>Manner and Timing of Designations</u> . Except as otherwise provided in this Order
2	(see, e.g., second paragraph of section 5.2(a) below), or as otherwise stipulated or ordered,
3	Disclosure or Discovery Material that qualifies for protection under this Order must be clearly so
4	designated before the material is disclosed or produced.
5	Designation in conformity with this Order requires:
6	(a) for information in documentary form (e.g., paper or electronic documents, but
7	excluding transcripts of depositions or other pretrial or trial proceedings), that the
8	Producing Party affix the legend "CONFIDENTIAL" to each page that contains
9	protected material. If only a portion or portions of the material on a page qualifies for
10	protection, the Producing Party also must clearly identify the protected portion(s) (e.g.,
11	by making appropriate markings in the margins). A Party or Non-Party that makes
12	original documents or materials available for inspection need not designate them for
13	protection until after the inspecting Party has indicated which material it would like
14	copied and produced. During the inspection and before the designation, all of the
15	material made available for inspection shall be deemed "CONFIDENTIAL." After the
16	inspecting Party has identified the documents it wants copied and produced, the
17	Producing Party must determine which documents, or portions thereof, qualify for
18	protection under this Order. Then, before producing the specified documents, the
19	Producing Party must affix the "CONFIDENTIAL" legend to each page that contains
20	Protected Material. If only a portion or portions of the material on a page qualifies for
21	protection, the Producing Party also must clearly identify the protected portion(s) (e.g.,

If only a portion or portions of the information or item warrant 1 protection, the Producing Party, to the extent practicable, shall identify the protected 2 3 portion(s). 4 5.3 Inadvertent Failures to Designate. If timely corrected, an inadvertent failure to 5 designate qualified information or items does not, standing alone, waive the Designating Party's 6 right to secure protection under this Order for such material. Upon timely correction of a 7 designation, the Receiving Party must make reasonable efforts to assure that the material is treated 8 in accordance with the provisions of this Order. 9 CHALLENGING CONFIDENTIALITY DESIGNATIONS 6. 10 6.1 Timing of Challenges. Any Party or Non-Party may challenge a designation of 11 confidentiality at any time. The Challenging Party shall initiate the dispute resolution process 17 by providing written notice of each designation it is challenging and describing the basis for each 18 challenge. To avoid ambiguity as to whether a challenge has been made, the written notice must 19 recite that the challenge to confidentiality is being made in accordance with this specific paragraph 20 of the Protective Order. The parties shall attempt to resolve each challenge in good faith and must 21 begin the process by conferring directly (in voice to voice dialogue; other forms of communication 22 are not sufficient) within 14 days of the date of service of notice. In conferring, the Challenging 23 Party must explain the basis for its belief that the confidentiality designation was not proper and must give the Designating Party an opportunity to review the designated material, to reconsider the 24 25 circumstances, and, if no change in designation is offered, to explain the basis for the chosen 26 designation. In addition, 10 the Challenging Party may file a motion challenging a confidentiality designation at any time if 11 there is good cause for doing so, including a challenge to the designation of a deposition transcript 12 or any portions thereof. Any motion brought pursuant to this provision must be accompanied by a 13 competent declaration affirming that the movant has complied with the meet and confer 14 requirements imposed by the preceding paragraph.

The burden of persuasion in any such challenge proceeding shall be on the Designating
Party. Frivolous challenges, and those made for an improper purpose (e.g., to harass or impose
unnecessary expenses and burdens on other parties) may expose the Challenging Party to sanctions.
Unless the Designating Party has waived the confidentiality designation by failing to file a motion
to retain confidentiality as described above, all parties shall continue to afford the material in
question the level of protection to which it is entitled under the Producing Party's designation until
the court rules on the challenge.

### ACCESS TO AND USE OF PROTECTED MATERIAL

7.1 <u>Basic Principles</u>. A Receiving Party may use Protected Material that is disclosed or
produced by another Party or by a Non-Party in connection with this case only for prosecuting,
defending, or attempting to settle this litigation. Such Protected Material may be disclosed only to
the categories of persons and under the conditions described in this Order. When the litigation has
been terminated, a Receiving Party must comply with the provisions of section 13 below (FINAL
DISPOSITION). Protected Material must be stored and maintained by a Receiving Party at a

location and in a secure manner that ensures that access is limited to the persons authorized under
 this Order.

3	7.2 <u>Disclosure of "CONFIDENTIAL" Information or Items</u> . Unless otherwise ordered

14 no Party waives any right it otherwise would have to object to disclosing or producing any
15 information or item on any ground not addressed in this Stipulated Protective Order. Similarly, no
16 Party waives any right to object on any ground to use in evidence of any of the material covered by
17 this Protective Order.

18 12.3 Filing Protected Material. Without written permission from the Designating Party or 19 a court order secured after appropriate notice to all interested persons, a Party may not file in the 20 public record in this action any Protected Material. A Party that seeks to file under seal any 21 Protected Material must comply with Civil Local Rule 79-5. Protected Material may only be filed 22 under seal pursuant to a court order authorizing the sealing of the specific Protected Material at 23 issue. Pursuant to Civil Local Rule 79-5, a sealing order will issue only upon a request establishing that the Protected Material at issue is privileged, protectable as a trade secret, or otherwise entitled 24 25 to protection under the law. If a Receiving Party's request to file Protected Material under seal 26 pursuant to Civil Local Rule 79-5(d) is denied by the court, then the Receiving Party may file the 27 information in the public record pursuant to Civil Local Rule 79-5(e) unless otherwise instructed 28 by the court.

## 13. FINAL DISPOSITION

2 Within 60 days after the final disposition of this action, as defined in paragraph 4, each 3 Receiving Party must return all Protected Material to the Producing Party or destroy such material 4 As used in this subdivision, "all Protected Material" includes all copies, abstracts, compilations, 5 summaries, and any other format reproducing or capturing any of the Protected Material. Whether 6 the Protected Material is returned or destroyed, the Receiving Party must submit a written 7 certification to the Producing Party (and, if not the same person or entity, to the Designating Party) 8 by the 60 day deadline that (1) identifies (by category, where appropriate) all the Protected 9 Material that was returned or destroyed and (2) affirms that the Receiving Party has not retained 10 any copies, abstracts, compilations, summaries or any other format reproducing or capturing any of 11 the Protected Material. Notwithstanding this provision, Counsel are entitled to retain an archival 12 copy of all pleadings, motion papers, trial, deposition, and hearing transcripts, legal memoranda, 13 correspondence, deposition and trial exhibits, expert reports, attorney work product, and consultant 14 and expert work product, even if such materials contain Protected Material.
