1 **STIPULATION**

2 Plaintiff Michael Richardson and Defendant Xavier Becerra (together, the Parties)
3 stipulate as follows:

4 WHEREAS, pursuant to the Parties’ stipulation, this Court previously issued an order
5 continuing the Status (Pretrial Scheduling) Conference to April 4, 2018, at 10:00 a.m., and the
6 Parties’ deadline to file a Joint Status Report to March 21, 2018;

7 WHEREAS, Defendant Becerra filed a motion to dismiss certain causes of action in the
8 Complaint, which was heard by this Court on February 14, 2018;

9 WHEREAS, this Court issued its Findings and Recommendation on the motion to dismiss
10 on March 5, 2018, granting the motion without leave to amend, and providing a deadline of
11 March 26, 2018, for the parties to file any objections to the Findings and Recommendation, and
12 an additional fourteen (14) days after service of any objections to file any responses to them; and

13 WHEREAS, the Parties wish to continue the Status (Pretrial Scheduling) Conference and
14 associated deadlines until after the district court judge issues an order on Defendant’s motion to
15 dismiss;


