Henceforth, the 13 caption on documents filed in the reassigned cases shall be shown 14 as 1:17-CV-01317 JAM-AC, 2:17-CV-02006 JAM-AC, 2:17-CV-02051 JAM-AC, 2:17-02053 JAM-AC, 2:17-02079 JAM-AC, and 2:17-02092 JAM-AC. 15

16 IT IS FURTHER ORDERED that the Clerk of the Court make 17 appropriate adjustment in the assignment of civil cases to 18 compensate for this reassignment.
