
19 WHEREAS, a Verified Complaint for Forfeiture *In Rem* has been filed on November 9, 2017 in  
20 the United States District Court for the Eastern District of California, alleging that the defendant  
21 Approximately \$14,000.00 in U.S. Currency and the Approximately \$13,020.00 in U.S. Currency  
22 ("defendant currency") are subject to forfeiture to the United States pursuant to 21 U.S.C. § 881(a)(6) for  
23 one or more violations of 21 U.S.C. §§ 841 *et seq.*;

24 And WHEREAS, the Court being satisfied that, based on the Verified Complaint for Forfeiture  
25 *In Rem* and the affidavit of Trevor Covert, United States Postal Inspector with the United States Postal  
26 Inspection Service, there is probable cause to believe that the defendant currency so described  
27 constitutes property that is subject to forfeiture for such violation(s), and that grounds for the issuance  
28 of a Warrant for Arrest of Articles *In Rem* exist, pursuant to Rule G(3)(b)(i) of the Supplemental Rules

1 for Admiralty or Maritime Claims and Asset Forfeiture Actions;

2 IT IS HEREBY ORDERED that the Clerk for the United States District Court, Eastern District  
3 of California, shall issue a Warrant for Arrest of Articles *In Rem* for the defendant currency.
