25 schedule:

26 1. December 8, 2017: By this date, Plaintiffs shall file their motion for a preliminary  
27 injunction.

1           2.     January 16, 2018: By this date, Defendants shall file any response to Plaintiffs'  
2 motion for a preliminary injunction and shall answer or otherwise respond to the Plaintiffs' First  
3 Amended Complaint.

4           3.     February 6, 2018: By this date, Plaintiffs shall file any reply in support of their  
5 motion for a preliminary injunction, and any opposition to a response filed by Defendants other  
6 than an Answer.

7           4.     February 13, 2018: By this date, Defendants shall file any reply in support of any  
8 response filed by Defendants other than an Answer.

9           5.     February 20, 2018 at 1:30 p.m.: On this date, the Court will hold a hearing on  
10 Plaintiffs' motion for a preliminary injunction and any motion filed by Defendants on January  
11 16, 2018, in response to the First Amended Complaint.
