21 IT IS HEREBY STIPULATED, by and between the parties, through their respective  
22 counsel of record, that Plaintiff shall have an extension of time to June 14, 2018 to file his  
23 opening brief. The court previously granted Plaintiff's extension to file his motion for summary  
24 judgment on or before May 9, 2018. On April 26, 2018, Plaintiff's counsel sent a letter,  
25 notifying the office of Defendant's counsel that the administrative record was missing medical


