16	Defendants' counsel and will file that motion, if at all, on or before March 20, 2018. The	
17	Non-Municipal Defendants (and their counsel) intend to vigorously oppose Plaintiffs'	
18	motion.	
19	4. The Non-Municipal Defendants will respond (by motion or answer) to the	
20	Complaint, as amended, no later than 21 days after the later of when the amendments	
21	regarding the Non-Municipal Defendants are filed or the Court rules on Plaintiffs' motion	
22	for disqualification.
