18	Plaintiff, a state prisoner proceeding pro se, has filed a civil rights action pursuant to 42	
19	U.S.C. § 1983. Plaintiff has not, however, filed an in forma pauperis affidavit or paid the	
20	required filing fee of \$350.00 plus the \$50.00 administrative fee. ¹ See 28 U.S.C. §§ 1914(a),	
21	1915(a). Therefore, plaintiff will be provided the opportunity either to submit the appropriate	
22	affidavit in support of a request to proceed in forma pauperis or to submit the required fees	
23	totaling \$400.00.	
24	In addition, on January 18, 2018, plaintiff submitted a motion for monetary relief along	
25	with his complaint. This "motion" is not signed by plaintiff. Plaintiff is required to sign all

1	documents submitted to the court for filing. Fed. R. Civ. P. 11(a). Plaintiff is cautioned that he	
2	must sign all documents submitted in the future. Nonetheless, because plaintiff's complaint	
3	requests monetary damages, plaintiff is not required to file a separate motion for money damages.	
4	Therefore, plaintiff's motion is denied without prejudice.	
5	In accordance with the above, IT IS HEREBY ORDERED that:	
6	1. Plaintiff shall submit, within thirty days from the date of this order, an affidavit in	
7	support of his request to proceed in forma pauperis on the form provided by the Clerk of Court, or	
8	the required fees in the amount of \$400.00; plaintiff's failure to comply with this order will result	
9	in a recommendation that this action be dismissed;	
10	2. The Clerk of the Court is directed to send plaintiff a new Application to Proceed In	
11	Forma Pauperis By a Prisoner; and	
12	3. Plaintiff's motion (ECF No. 2) is denied without prejudice.
