DECLARATION OF ASSISTANT FIELD OFFICE DIRECTOR DOUGLAS B. ZIEGLER

I, Douglas B. Ziegler, hereby declare and state as follows:

- 1. I am currently an Assistant Field Office Director with U.S. Department of Homeland Security (DHS), U.S. Immigration and Customs Enforcement (ICE), U.S. Enforcement and Removal Operations (ERO). I have held this position since November 26, 2017. I started working in the immigration field as a United States Border Patrol Agent on July 20, 1997 and have just under 21 years working in this field as a law enforcement agent and officer. On January 6, 2006, I became a Deportation Officer in Richmond, VA. In March 2013, I was promoted to Supervisory Detention and Deportation Officer. In the year 2013, I transferred to San Diego. I have worked in many ERO units including Prosecutions, Criminal Alien Program (CAP), Fugitive Operations (FOU), Intake, Travel, Juvenile, Family Unit, Detention, and Detained. I currently supervise the FOU as a second line supervisor.
- 2. The statements contained in this declaration are based upon my personal knowledge or upon information provided to me in my official capacity.

- 3. As part of my duties, electronic data bases are used to identify and apprehend aliens illegally present in the United States with a primary focus upon individuals who pose a danger to public safety or who are fugitives.
- 4. As a supervisor over the FOU and CAP Units, officers under my supervision work to arrest at-large illegal aliens and lodge immigration detainers on illegal aliens who are in local, state, and federal custody who have prior criminal records, pending criminal charges, or those who have otherwise violated immigration law.
- 5. The criminal alien unit monitors all arrests and book-ins within San Diego County. When a person in County custody is identified as being in the country illegally or is otherwise deportable from the United States, ERO issues a detainer to the San Diego County Sherriff's Department (SDSO). The detainer is reviewed by them to determine if the prior or pending criminality qualifies for ERO notification within the requirements of SB 54.
- 6. If a detainee does not meet the specifications identified in SB 54 for ICE notification, the SDSO releases the detainee, to the street, without notifying ERO. When ERO becomes aware of the release without notification of release, the case is referred to the FOU for targeting and arrest. Conducting unnecessary at large arrests puts communities and law enforcement personnel in unnecessary danger, due to the uncertainty of an uncontrolled environment. Data collected from January 1, 2018 to June 3, 2018 by ERO San Diego reveals that 622 detainers have been filed, 273 detainers have been accepted, and 349 detainers have been declined by SDSO.
- 7. If an illegal alien meets the requirement of SB 54, the SDSO notifies ERO by email and fax of the location, date, and time of release. The notification allows ERO to respond accordingly, i.e. receive the alien directly from the law enforcement agency within the controlled detention area, with no risk to the community wellbeing.
- 8. Absent SDSO notification of pending release; ERO is required to monitor an SDSO public website, "Who's In Jail" https://apps.sdsheriff.net/wij/pendrelease.aspx. This website provides public information concerning the initiation of the SDSO release process, there is no information concerning the actual release time.

- 9. ERO doesn't have direct access to CLETS; information received from CLETS is obtained through other systems, which probes CLETS for related information.
- 10. ERO San Diego is not aware of any database that provides a projected release date and time.
 The time and date of the release can be queried after the release has been finalized.

I declare, under penalty of perjury under 28 U.S.C. § 1746, that the foregoing is true and correct to the best of my knowledge, information, and belief.
