We write to schedule an initial visit and tour of the areas of James A. Musick Facility where immigration detainees are held. This visit and tour will be conducted pursuant to Government Code Section 12532, as well as the Attorney General's authority under the California Constitution, article V, section 13.

Government Code section 12532 requires the Attorney General to engage in reviews of county, local, or private locked detention facilities in which noncitizens are being housed or detained for purposes of civil immigration proceedings in California. Section 12532, subdivision (c) specifically provides that the Attorney General's Office "shall be provided all necessary access for the reviews and observations required pursuant to this section, including, but not limited to, access to detainees, officials, personnel, records, and any other information."

We have made arrangements with our review team to visit and tour the immigration detainee areas of James A. As part of the tour of immigration detainee areas, we request access to housing units, administrative and disciplinary segregation units, medical units and any areas where medical attention is provided, the law library, the dining facilities and food preparation areas, laundry facilities, the indoor and outdoor recreation areas, the commissary, the visitation and legal visitation areas, and all areas in which detainees have access to telephones. During the tour, we will need to informally speak with detainees and facility staff as time allows.

Prior to our visit, we also request a copy of the Facility Handbook and other materials distributed for detainee orientation; blank Detainee Request forms, Detainee Medical Request
