7 Examination of the above-entitled actions reveals that these
8 actions are related within the meaning of Local Rule 123 (E.D. Cal.

21 reassigned to Judge John A. Mendez and Magistrate Judge Allison
22 Claire for all further proceedings, and any dates currently set in
23 this reassigned case only are hereby VACATED. Henceforth, the
24 caption on documents filed in the reassigned cases shall be shown
25 as 2:18-CV-00548 JAM-AC, 2:18-CV-00550 JAM-AC, and 2:18-CV-00551
26 JAM-AC.
