1	Accordingly, IT IS HEREBY ORDERED that:	
2	1. Plaintiff's request for an extension of time to file an application to proceed in forma	
3	pauperis (ECF No. 15) is granted.	
4	2. Plaintiff is granted thirty days from the service of this order in which to file a	
5	completed in forma pauperis application. If plaintiff is unable to comply with this order, he must	
6	submit to the court a copy of his request for a copy of his certified trust account statement along	
7	with any responses received from jail officials. Failure to comply with this order may result in	
8	dismissal.	
9	3. The Clerk of the Court is directed to send plaintiff a new Application to Proceed In	
10	Forma Pauperis By a Prisoner.	
11	4. The Clerk of the Court shall serve a courtesy copy of this order on Lieutenant Ramos at	
12	the Sacramento Main Jail, 651 I Street, Sacramento, CA 95814.
