27	$\frac{1}{1}$ If possible, the parties should file jointly. If this is not possible the parties are instructed to file	
28	individual reports and state why they could not file jointly.	

1	d. Jurisdiction and venue;	
2	e. The report required by Federal Rule of Civil Procedure 26 outlining the proposed	
3	discovery plan and its scheduling, including disclosure of expert witnesses;	
4	f. Anticipated motions and their scheduling, including setting appropriate cut-off	
5	dates for discovery and law and motion;	
6	g. Special procedures, if any;	
7	h. Whether the case is related to any other cases, including bankruptcy;	
8	i. Whether a settlement conference should be scheduled, and if so, whether (A) the	
9	parties will stipulate to the magistrate judge assigned to this matter acting as settlement	
10	judge and waiving disqualification by virtue of his so acting, or (B) they prefer to have a	
11	settlement conference conducted before another judge;	
12	j. Whether any default proceedings are anticipated; and	
13	k. Any other matters that affect the just and expeditious disposition of this matter.
