24	was seized on August 14, 2017.	
25	2. The Drug Enforcement Admin	nistration has sent the written notice of intent to forfeit
26	required by 18 U.S.C. § 983(a)(1)(A) to all k	nown interested parties. The time has expired for any
27	person to file a claim to the defendant curren	cy under 18 U.S.C. § 983(a)(2)(A)-(E), and no person other
28	than claimant has filed a claim to the defendation	ant currency as required by law in the administrative

forfeiture proceeding.

Under 18 U.S.C. § 983(a)(3)(A), the United States is required to file a complaint for
 forfeiture against the defendant currency and/or to obtain an indictment alleging that the defendant
 currency is subject to forfeiture within ninety days after a claim has been filed in the administrative
 forfeiture proceeding, unless the court extends the deadline for good cause shown or by agreement of the
 parties. That deadline was January 18, 2018.

4. By Stipulation and Order filed January 17, 2018, the parties stipulated to extend to
February 16, 2018, the time in which the United States is required to file a civil complaint for forfeiture
against the defendant currency and/or to obtain an indictment alleging that the defendant currency is
subject to forfeiture.

5. By Stipulation and Order filed February 15, 2018, the parties stipulated to extend to April
17, 2018, the time in which the United States is required to file a civil complaint for forfeiture against the
defendant currency and/or to obtain an indictment alleging that the defendant currency is subject to
forfeiture.

By Stipulation and Order filed April 20, 2018, the parties stipulated to extend to May 17,
 2018, the time in which the United States is required to file a civil complaint for forfeiture against the
 defendant currency and/or to obtain an indictment alleging that the defendant currency is subject to
 forfeiture.

19 7. As provided in 18 U.S.C. § 983(a)(3)(A), the parties wish by agreement to further extend
20 to June 15, 2018, the time in which the United States is required to file a civil complaint for forfeiture
21 against the defendant currency and/or to obtain an indictment alleging that the defendant currency is
22 subject to forfeiture.
