The Clerk of the Court is further directed to serve a copy of this order on the United 23 States Marshal. 24 25 3. Within fourteen days from the date of this order, plaintiff shall submit to the United 26 States Marshal a completed summons and copies of the complaint and to file a statement with the 27 court that said documents have been submitted to the United States Marshal. 28 4. The United States Marshal is directed to serve all process without prepayment of costs 1

1	not later than sixty days from the date of this order. Service of process shall be completed by
2	delivering a copy of the summons and complaint to the United States Attorney for the Eastern
3	District of California, and by sending a copy of the summons and complaint by registered or
4	certified mail to the Attorney General of the United States at Washington, D.C. See Fed. R. Civ.
5	P. 4(i)(1)(A) & (B). The Marshal shall also send a copy of the summons and complaint by
6	registered or certified mail to the Commissioner of Social Security, c/o Office of the General
7	Counsel, Region IX, 160 Spear Street, Suite 800, San Francisco, CA 94105-1545. See Fed. R.
8	Civ. P. 4(i)(2).
9	5. The parties are hereby notified that, after service of the complaint and with the
10	exception of filing consent/decline forms, this action will be stayed pursuant to General Order
11	Number 615, and there will be no scheduling order or deadlines in effect pending further order of
12	the court. See E.D. Cal. G.O. No. 615, Paragraphs 6,10.
13	6. The Clerk is directed to issue the Consent/Decline forms only. Pursuant to G.O. 615,
14	no Briefing Schedule shall issue.
