1 Pursuant to United States District Court, Eastern District of California Local Rule
2 143, the following Stipulation is entered into by Plaintiff Marie Stanley (“Plaintiff”), and
3 Defendants Kelly Services, Inc. (“KSI”) and Centene Corporation (“Centene”) (KSI and
4 Centene are, together, “Defendants”) (Plaintiff and Defendants are, collectively, the
5 “Parties”) by and through their counsel of record:

6 WHEREAS, on February 28, 2020, the Court issued an Order Setting Status (Pretrial
7 Scheduling) Conference for July 9, 2020 (ECF No.7);

8 WHEREAS, on April 3, 2020, KSI filed a Motion to Compel Arbitration and Stay
9 Proceedings (“KSI’s Motion”) (ECF No. 13);

10 WHEREAS, on April 9, 2020, Centene filed a Motion to Compel Arbitration and
11 Dismiss Or Stay Proceedings and Joinder to KSI’s Motion (“Centene’s Motion”) (ECF No.
12 17) (together, KSI’s Motion and Centene’s Motion are referred to herein as the “Motions”);

13 WHEREAS, the Motions have been fully briefed and are pending before the Court;

14 WHEREAS, there was a Status (Pretrial Scheduling) Conference scheduled in this
15 matter for July 9, 2020;

16 WHEREAS, on June 24, 2020, the Parties filed a Stipulation and (Proposed) Order to
17 continue the July 9, 2020 Status (Pretrial Scheduling) conference in light of the pending
18 Motions (ECF No. 24);

19 WHEREAS, the Court issued a Minute Order on July 1, 2020, resetting the July 9,
20 2020 Status (Pretrial Scheduling) Conference for October 8, 2020;

21 WHEREAS, on September 21, 2020, the Court issued a Minute Order resetting the
22 October 8, 2020 Status (Pretrial Scheduling) Conference for December 3, 2020 in light of
23 the pending Motions (ECF No. 28);

24 WHEREAS, the Motions remain pending;

25 WHEREAS, the Parties seek to preserve the time and resources of the Parties and the
26 Court in the event that the Court grants the Motions;

27 IT IS HEREBY STIPULATED AS FOLLOWS:

28 The December 3, 2020 Status (Pretrial Scheduling) Conference is continued to

1 February 11, 2021, or to such a date following the Court's rulings on KSI's Motion and
2 Centene's Motion as the Court may set. The deadlines to complete pre-Status Conference
3 tasks, including, but not limited to, the Parties meeting and conferring as contemplated by
4 Federal Rule of Civil Procedure 26 and Local Rule 240(b) and submission of a Joint Status
5 Report that includes the Rule 26(f) discovery plan, are similarly continued to dates
6 consistent with the continued February 11, 2021 Status Conference.
