20 IT IS STIPULATED by and between Plaintiff (“Plaintiff”) and Defendant Kilolo
21 Kijakazi, Acting Commissioner of Social Security (“Defendant”), through their undersigned
22 counsel of record, that the above-entitled action shall be remanded to the Commissioner of
23 Social Security for further administrative proceedings.

24 Upon remand, the Office of Hearing Operations will remand the case to an
25 Administrative Law Judge (ALJ) for a new decision, and instruct the ALJ to re-evaluate the
26 evidence of record. In doing so, the ALJ will offer Plaintiff the opportunity for a new hearing,
27 take further action as necessary to complete the administrative record, and issue a new decision.

1 The parties further request that the Court direct the Clerk of the Court to enter a final judgment
2 in favor of Plaintiff, and against Defendant, reversing the final decision of the Commissioner.

3 This stipulation constitutes a remand under the fourth sentence of Section 205(g) of the
4 Social Security Act, 42 U.S.C. 405(g).
