17	On June 3, 2021, I screened petitioner's petition for writ of habeas corpus, notified him	
18	that it failed to state a claim, and granted him sixty days to file an amended petition. ECF No. 12.	
19	Petitioner failed to timely file an amended petition. Accordingly, on November 8, 2021, I ordered	
20	petitioner to show cause within twenty-one days why this action should not be dismissed for his	
21	failure to prosecute and for failure to state a claim. ECF No. 13. I notified him that if he wished	
22	to continue with this action he must file, within twenty-one days, an amended petition. <i>Id.</i> I also	
23	warned him that failure to comply with that order would result in a recommendation that this	
24	action be dismissed. <i>Id</i> .	
25	The deadline has passed, and petitioner has not filed an amended petition nor otherwise	
26	responded to the November 8, 2021 order. Accordingly, it is hereby RECOMMENDED that:

1	1. This action be dismissed for failure to prosecute, failure to comply with court orders,	
2	and for failure to state a claim for the reasons set forth in the court's June 3, 2021 order. See ECF	
3	No. 12.	
4	2. The Clerk of Court be directed to close the case.	
5	I submit these findings and recommendations to the district judge under	
6	28 U.S.C. § 636(b)(1)(B) and Rule 304 of the Local Rules of Practice for the United States	
7	District Court, Eastern District of California. The parties may, within 14 days of the service of	
8	the findings and recommendations, file written objections to the findings and recommendations	
9	with the court. Such objections should be captioned "Objections to Magistrate Judge's Findings	
10	and Recommendations." The district judge will review the findings and recommendations under	
11	28 U.S.C. § 636(b)(1)(C).
