1 WHEREAS, James Eads filed Answer and Counterclaims of Defendant James Eads on July
2 6, 2022 (Dkt No. 20) that raised two counts—one for Breach of Contract and the other for
3 Declaratory Relief (the “Counterclaims”);

4 WHEREAS, Plaintiff and Counter-Defendant Rehan S. Alvi’s response to the Counterclaims
5 is due on Wednesday, July 27, 2022;

6 WHEREAS, Mr. Alvi is contemplating filing a motion to dismiss the Counterclaims;

7 WHEREAS, the Parties have a Settlement Conference set for August 31, 2022 (the
8 “Settlement Conference”);

9 WHEREAS, the Parties desire to preserve party and judicial resources prior to the Settlement
10 Conference and, therefore, desire to extend the time for Mr. Alvi to respond to the Counterclaims;

11 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED among the Parties
12 through their respective counsel to the entry of an Order providing that:

- 13 1. Plaintiff and Counter-Defendant Rehan S. Alvi shall have until September 30, 2022 to
14 file a response to the Counterclaims.


