16 b. Expert Witness Disclosures (Initial): March 7, 2025
17 c. Expert Witness Disclosures (Supplemental): April 11, 2025
18 d. Dispositive Motions Shall Be Filed by: June 6, 2025
19 e. Joint Notice of Trial Readiness (if no dispositive motions): March 13,
20 2025.
21 f. Joint Notice of Trial Readiness (if dispositive motion filed): 30 days
22 after the Court’s ruling on the last filed dispositive motion.
