 16 IT IS STIPULATED, by and between the parties, through their respective counsel of record,
 17 that the time for Plaintiff to file her motion for summary judgment be extended an additional 30
 18 days from the existing deadline such that Plaintiff’s new deadline, with the Court’s approval, will

 26 with a family illness. With the Court’s approval, the parties further stipulate that all other dates in
 27 the Court’s Scheduling Order be extended accordingly alongside Plaintiff’s extension.
