On March 28, 2024, the undersigned recommended that this action be dismissed for plaintiff's failure to file an amended complaint or otherwise respond to the court's order filed on February 16, 2024. However, the court has determined that plaintiff submitted a complaint which was entered as a new case on May 30, 2023, and which, instead, should have been filed as plaintiff's amended complaint in this case. Accordingly, the undersigned will vacate the findings and recommendations to dismiss this case for failure to file an amended complaint. By separate order in the other action, the undersigned will order the Clerk
