[Dkt. No. 1.] Shortly thereafter, the Parties informed the 19 Court they would be attending mediation on April 2, 2024, and submitted a stipulation to stay the 20 action and continue the deadlines for Defendant to respond to the Complaint and for Plaintiff to 21 file a motion to remand until May 17, 2024; this Court granted the stipulation on September 6, 22 2023. [Dkt. No. 5.] 23 On May 3, 2024, the Parties filed a Notice of Settlement, informing the Court that the 24 Parties settled the matter at mediation on April 2, 2024 and were in the midst of satisfying their 25 duties as mandated by the settlement agreement. On May 3, 2024, the Parties filed a stipulation 26 to dismiss the class claims and stay the action pending dismissal of Plaintiff's individual claims; 27 this Court granted the stipulation on May 9, 2024, thereby dismissing the putative class claims. 28

1	Now pending before the Court is the Parties' Joint Stipulation of Dismissal Pursuant to
2	F.R.C.P. 41(a)(1)(A)(i), in which the Parties seek to dismiss Plaintiff's individual claims and
3	complaint. Defendant has not responded to the Complaint and thus voluntary dismissal under
4	F.R.C.P. 41(a)(1)(A)(i) is appropriate.
5	Accordingly, the Parties' joint stipulation to dismiss Plaintiff's individual claims, with
6	prejudice, is hereby GRANTED . Pursuant to the stipulation, the Court ORDERS the following:
7	(1) Plaintiff's claims and complaint are HEREBY DISMISSED;
8	(2) each Party shall bear their own attorneys' fees and costs, except as provided in the
9	Settlement Agreement; and
10	(3) the Clerk of the Court is HEREBY DIRECTED to close the case.
11	IT IS SO ORDERED.
