11	c. An estimate of the cost and time to be expended for further discovery, pretrial, and
12	trial.
13	d. The party's position on settlement, including present demands and offers and a
14	history of past settlement discussions, offers, and demands.
15	e. A brief statement of each party's expectations and goals for the settlement
16	conference, including how much a party is willing to accept and/or willing to pay.
17	f. If parties intend to discuss the joint settlement of any other actions or claims not in
18	this suit, give a brief description of each action or claim as set forth above,
19	including case number(s) if applicable.
20	6. If a settlement is reached at any point during this action, the parties shall file a Notice
21	of Settlement in accordance with Local Rule 160.
22	7. <u>Defense counsel shall contact the Litigation Coordinator at the institution where</u>
23	Plaintiff is housed to determine whether the institution can accommodate a Zoom
24	video appearance by Plaintiff at this date and time.
25	8. The parties remain obligated to keep the Court informed of their current address at all
26	times while the action is pending. Any change of address must be reported promptly
27	to the Court in a separate document captioned for this case and entitled "Notice of

1	Change of Address." See Local Rule 182(f).
2	9. <u>A failure to follow these procedures may result in the imposition of sanctions by</u>
3	<u>the court.</u>
4	10. Judge Boone or another representative from the court will be contacting the parties
5	either by telephone or in person, approximately two weeks prior to the settlement
6	conference, to ascertain each party's expectations of the settlement conference.
7	11. The Clerk of the Court is directed to serve a copy of this order via fax on the
