1 Anthony L. Robinson (“Robinson”) (E-91884), is confined in the California State Prison–
2 Sacramento (“CSP–Sac”) in Represa, California 95671, and the plaintiff in the above-captioned
3 action, which is set for trial beginning on May 10, 2010 and continuing through at least May 14,
4 2010. Robinson is a necessary and material witness as his case depends in large measure on his
5 own testimony. To prepare for and attend trial, Robinson respectfully requests that this Court
6 issue a writ requiring the California Department of Corrections and Rehabilitation (“CDCR”):
7 (1) to transfer Robinson to San Quentin State Prison no later than May 4, 2010; (2) to transfer
8 Robinson to the U.S. District Court, 450 Golden Gate Ave., 17th floor, Courtroom 2 in San
9 Francisco, California by 8 a.m. every day during trial commencing May 10, 2010, or as otherwise
10 ordered by the Court; and (3) to transfer Robinson back to CSP–Sac as soon as the trial is
11 completed.

12 **ACCORDINGLY, IT IS HEREBY ORDERED** that:

13 **1.** A Writ of Habeas Corpus Ad Testificandum issue, under seal of this Court,
14 directing the CDCR: (1) to transfer Robinson to San Quentin State Prison no later than May 4,
15 2010; (2) to transfer Robinson to the U.S. District Court, 450 Golden Gate Ave., 17th floor,
16 Courtroom 2 in San Francisco, California every day by 8:00 a.m. during trial commencing May
17 10, 2010, or as otherwise ordered by the Court; and (3) to transfer Robinson back to CSP–Sac as
18 soon as the trial is completed.

19 **2.** The CDCR is ordered to notify the Court of any change in Robinson’s custody and
20 to provide the new custodian with a copy of this writ; and

21 **3.** Plaintiff is directed to serve a courtesy copy of this Writ of Habeas Corpus Ad
22 Testificandum and Order to the Out-to-Court Desk, CSP–Sac in Represa, California 95671.

23 **4.** Plaintiff is directed to serve a courtesy copy of this Writ of Habeas Corpus Ad
24 Testificandum and Order to Legal Affairs, San Quentin State Prison, 1 Main Street, San Quentin,
25 CA 94964.
