 21 IT IS HEREBY STIPULATED by and between the parties, through their undersigned attorneys,
 22 and with the approval of the Court, that the Commissioner of Social Security has agreed to a voluntary
 23 remand of this case pursuant to sentence four of 42 U.S.C. § 405(g). On remand, the Appeals Council
 24 will direct the Administrative Law Judge to:

- 25 • Further develop the record and based on the expanded record, conduct the sequential evaluation
 26 process;
- 27 • Reevaluate the claimant’s allegations, the third-party statements and the opinion evidence, in

1 accordance with the applicable rules, and make new findings;

- 3 • Offer the claimant the opportunity for a new hearing; obtain vocational expert evidence as
4 needed, and issue a new decision.

5 The parties further request that the Clerk of the Court be directed to enter a final judgment in
6 favor of Plaintiff, and against Defendant, reversing the final decision of the Commissioner.
