I'VE BEEN IN CELL 3-EY-50, 3-EY-31, 3-EY-22, 3-EY-21 AND CELL 3-EY-15 ALL THIS YEAR. GRUNDY ALLOWS CORRUPT GUARDS TO RUN EASTBLOCK THIS QUARDY. LT HENSON, SGT ERICSSON, ARE CORRUPT JOKES. THIS IS TO DELIBERATELY DAMAGE, LOSE OR STEAL MY PROPERTY.

CAPT GRUNDY ENFORCES THE CODE OF SILENCE, ALLOWING GUARDS TO CREATE A HOSTILE CRIMINAL CONDIKON ON DEATH ROW. LT HENSON, SGT HUI, SGT ERICSSON, SGT ANDREW DEPRIVE ME OF ALL MAIL INCLUDING LEGAL MAIL. LT HENSON WITH CAPT GRUNDY'S FULL KNOWLEDGE SAID I WILL BE FOUND DEAD AS SUICIDE. GRUNDY PLACES ONLY GUARDS WHO HONOR CODE OF SILENCE AND ENACT REPRISALS ON 3RD FLOOR EASTBLOCK

Dear Mr. Stanley:

This is in response to your correspondences dated March 3, 2008 and July 25, 2008, the Honorable Judge Thelton Henderson regarding the medical care and treatment you are receiving at California State Prison – San Quentin (SQ), California Department of Corrections and Rehabilitation. Your correspondence was forwarded to the Controlled Correspondence and Litigation Management Unit (CCLMU) for review. I have been asked to respond to your concerns.

In your correspondences, you state you were denied medical care for severe chest pains because of a shift change on February 27, 2008. You also state you had still not received medical care or your nitroglycerin for your chest pains six days later. You further state medical care on death row is getting worse not better and correctional officers do not report medical problems, cover up misconduct, and put a stop on all appeals regarding medical issues and staff complaints. You request intervention on your behalf to address your health care concerns.

THIS IS A STAFF MISCONDUCT COMPLAINT AND IS NOT TO BE PROCESSED AS A STANDARD INMATE / PAROLEE APPEAL FORM CDCR 602 (12/87). PER CCR 15 3084.5 (3) (G) NO INFORMAL REVIEW IS REQUIRED. Complainant requests that this complaint be sent to and processed by CDCR "Internal Affairs" personnel.

STATEMENT OF ALLEGED MISCONDUCT

AS REPRISAL FOR MY ATTORNEYS AND I CONTACTING MEDIA, COURTS ABOUT ASSAULT-THREATS BY STAFF. I AM CURRENTLY BEING DENIED LEGAL MAIL, DENIED LAW LIBRARY, DENIED MEDICAL CARE BY ORDERS OF [REDACTED], LT HENSON, CAPT GRUNDY. (SEE ATTACHED DIRECTORS LEVEL DECISION ON THREATS, ASSAULT.) MAY 15, 08 DURING UNIT SEARCH MY CELL TOTALLY DESTROYED, 602 TO SGT HAGERMAN THE SAME DAY DESTROYED BY SGT HAGERMAN & SGT ERICKSON LT HENSON, SGT ERICKSON, SGT AMRHEIN WITHHOLD EVERY SINGLE PIECE OF LEGAL MAIL, ASKING LT ARUOLO TO INVESTIGATE HIS FELLOW LT IS A OUTRAGEOUS JOKE ARUOLO IS THE POSTER CHILD FOR CORRUPTION! REPRISALS. HE IS A ABSOLUTE JOKE. NO SOONER DID HE DELIBERATELY INTERVIEW THE WRONG WITNESSES BUT HE STARTED THE REPRISALS AT ONCE. CAPT GRUNDY ALLOWS - ENCOURAGES HIS 3RD WATCH STAFF TO LEAVE INCOMING MAIL, NEWSPAPERS, MAGAZINES, EVEN LEGAL MAIL OUT AROUND INMATE WORKERS, AND STAFF HE KNOWS STEAL INCOMING PAPERS, MAGAZINES EVEN LEGAL MAIL. NON-CONDEMNED INMATES HAVE DAILY ACCESS TO OUR RAZOR BOB ON 3RD TIER EAST BLOCK AND LOST OR SHAVED RAZORS ONLY A MATTER OF TIME UNDER THIS CAPT GRUNDY WHO ENJOYES CODE OF SILENCE IN EAST BLOCK. CAPT GRUNDY ALLOWS NON-CONDEMNED INMATES IN OUR CELLS TO PAINT WITH ALL OUR PROPERTY, CANTEEN, PACKAGE ITEMS TOTALLY AVAILABLE. ONE INMATE WORKER IS INVOLVED

TO REMOVE MY STAMPS, CANTEEN SATO INMATE JONES.

I, Jerry Stanley, declare as follows:

I am the defendant in this action and am housed at San Quentin State Prison. The harassment I am forced to endure on a daily basis at San Quentin is unbearable. My incoming and outgoing legal and regular mail is tampered with, delayed, and intentionally diverted. I ~~AM~~^{AM} high risk medical patient and have not had any of my medical appointments since last March when my appointments were cancelled because I was brought to Butte County. My name has been forged on medical refusal forms. My cell is regularly searched/ransacked outside my presence in violation of prison rules. I am frequently made to wait for unnecessarily hours in “stand up” cages when moved from my cell solely for purposes of harassment.

The harassment has gotten worse since the time my writ of habeas corpus was granted by the federal district court. I believe it is being carried out for purposed of persuading me to waive the relief granted and/or to cooperate by providing information related to another unsolved homicide.
